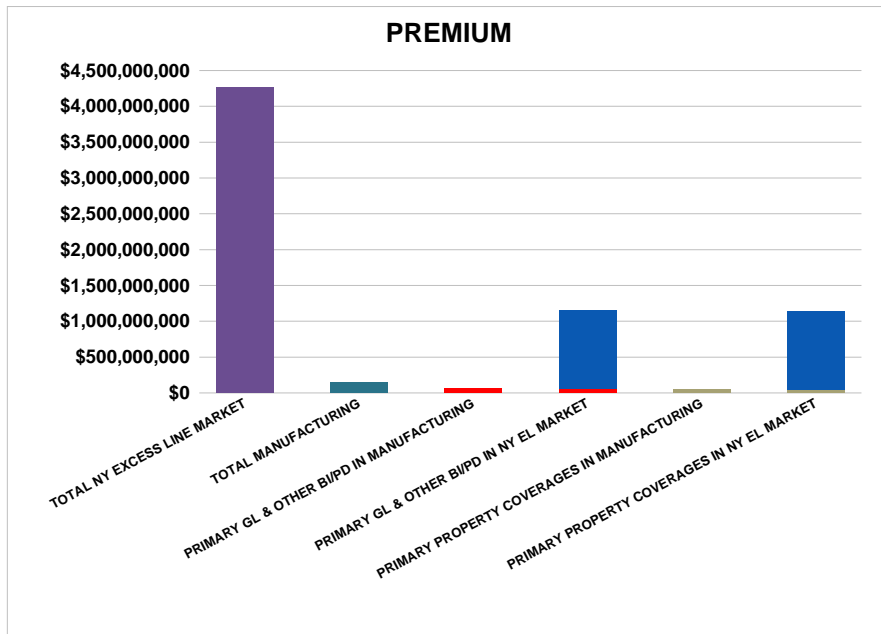

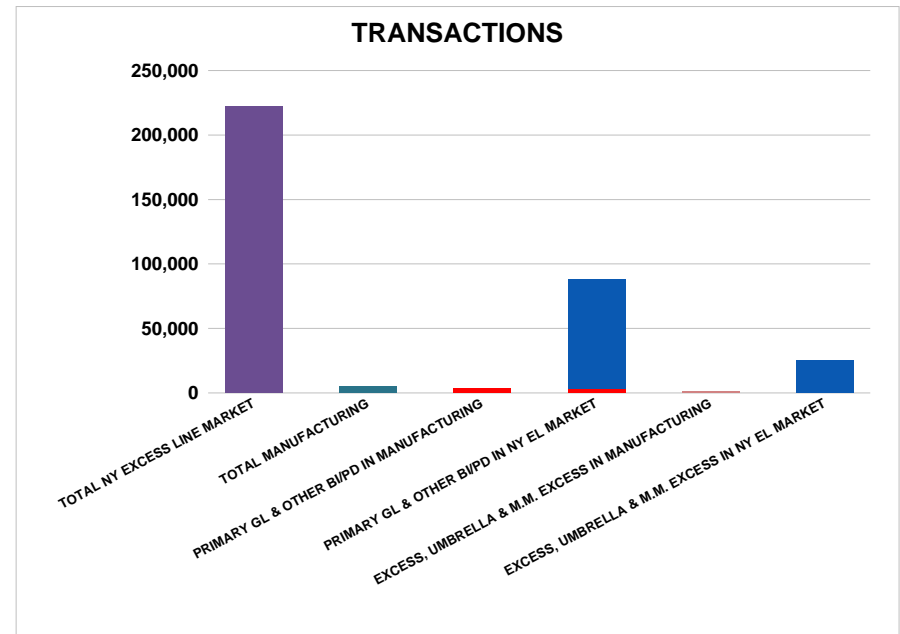
Manufacturing Risk Transactions of 5,247 constituted 2.36% of total YTD JUNE 2024 New York Excess Line Transactions.

**PRIMARY PROPERTY COVERAGES** Manufacturing Premium of \$51,077,530 represents 34.60% of all Manufacturing Risk Premium and 4.69% of all YTD JUNE 2024 PRIMARY PROPERTY COVERAGES Premium.
