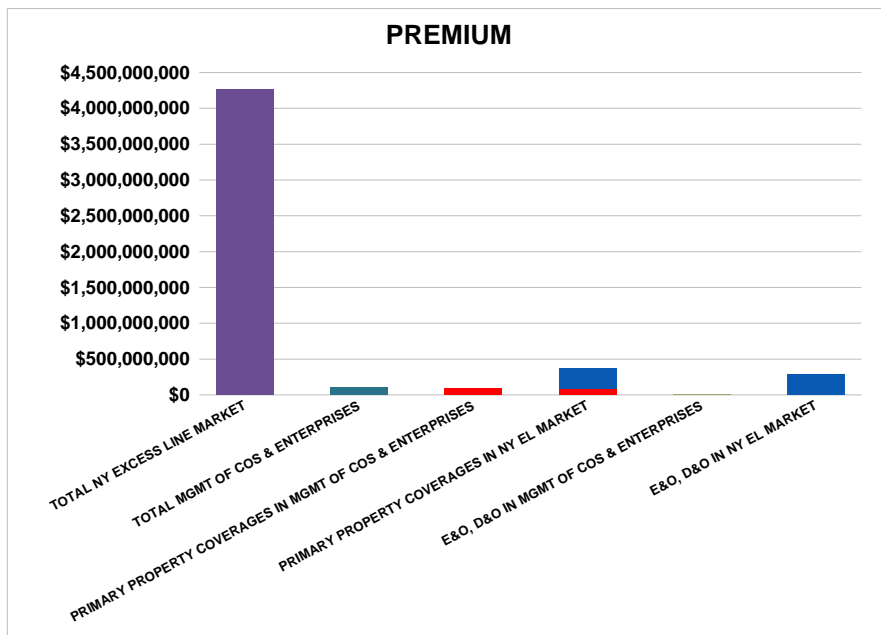

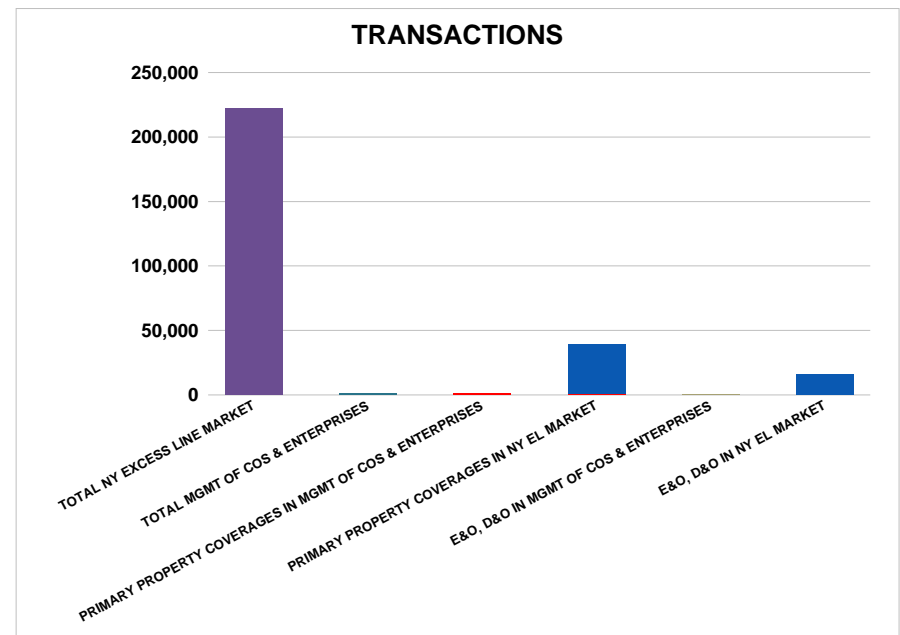
Management Of Companies And Enterprises Risk Transactions of **991** constituted **0.45%** of total YTD JUNE 2024 New York Excess Line Transactions.
